

Keller Chiropractic Financial Policy -2012

Keller Chiropractic accepts Medicare, Medicare Advantage Plans and Medicare Supplemental Plans, Ohio Bureau of Workers Compensation, Ohio State University Health Plans and Ohio State University Student Health. If you have one of these insurances you will be responsible for any deductibles, co-pays and non-covered services and supplies.

If you have any other insurance you will be responsible to pay in full on the day of service. We will provide you with a receipt that you can send to your insurance for reimbursement. You may want to check with your insurance to see if they will reimburse you for out of network services. If your insurance requires a special form, we can provide the CMS-1500 form, but there may be a processing fee.

Doctor Keller is certified by Ohio Bureau of Workers Compensation to treat injured workers. Approval must be obtained from the BWC or MCO before care can commence.

If your injuries are the result of an automobile accident, please note, we do not take assignment for personal injury claims **unless specific arrangements are made** to bill the med pay benefit on your car insurance. If we cannot bill the med pay portion of your insurance you should be prepared to pay at the time of service. We will give you a receipt, which you can send to the insurance company.

Dr. Keller is a participating provider for Medicare. Please read and sign separate Medicare policy.

We do not accept Medicaid or Coresource but we do offer a sliding fee scale for qualified patients. Please talk to us if you need care but are concerned about the cost.

Vitamins, supplements, educational books, equipment, supports and braces are a separate charge and will need to be paid on the day of service.

Payments can be made by check, cash or credit card (Discover, MasterCard, or Visa).

COMMON CHARGES:

NEW PATIENT VISIT: \$98.00 – Up to 60 minutes for new patient evaluation and treatment.

STANDARD VISIT: \$39.00 plus up to \$21 for therapy such as ultrasound or electrical stimulation. Up to 15 minutes of one-to one time with doctor.

DECOMPRESSION THERAPY: lumbar spine \$42.00, cervical spine \$21.00

EXTENDED VISIT \$60.00 plus up to \$21 for therapy such as ultrasound or electrical stimulation
Up to 30 minutes of one-to one time with the doctor for complex or new condition or re-exam.

PREPAID VISIT PACKAGE 6 visits at \$33 = \$198.00 plus discounted therapies
Up to 15 minutes of of one-to one time with the doctor per visit. Purchase of 6 visit package entitles half price on therapies such as ultrasound or electrical stimulation.

THERAPEUTIC MODALITIES such as ultrasound, electrical stimulation, exercise training and myofascial therapy fees range from \$15 to \$21. Medicare and Prepaid visits qualify for half-price fees for therapies.

MEDICARE is billed according to Medicare rules regarding prevailing fees, covered and non-covered charges, deductibles and co-pays in force at the time of visit. Please contact the office staff for details. Medicare aged patients qualify for half-price on therapies such as ultrasound and electrical therapy.
